

hhgregg XBOX One Bundle Twitter Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

The hhgregg Xbox One Bundle Twitter Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (including District of Columbia) thirteen (13) years or older at the time of entry. Void in Guam, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Employees of hhgregg or Microsoft or any of its affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. 4. How to Enter

To enter you must follow @hhgregg on <http://www.Twitter.com/hhgregg> and enter at <https://a.pgtb.me/Bqz1gC> when prompted during the Twitter takeover on September 12, 2016 from 6:00 PM EDT to 7:00 PM EDT.

Online entries will be deemed submitted by the authorized account holder of the email address submitted at time of entry. By entering, you agree to be bound by these Official Rules.

Unlimited entries during the Sweepstakes Period. Use of any automated system to enter is prohibited and will result in disqualification. Sponsors are not responsible for lost, late, incomplete, invalid, illegible or misdirected entries, which will be disqualified. Entries submitted or completed by anyone other than the entrant are void. Sponsors will not confirm receipt of entries. The time of receipt of any valid

Twitter entry shall be the time such valid entry becomes available to Sponsors on Twitter.com. Sponsors' computer shall be the official clock of the Sweepstakes.

5. Winner Selection and Notification

On September 12, 2016, a random drawing from among all eligible entries will be conducted under Sponsors' supervision. Potential winner will be notified by a winner announcement tweet and asked to send a Twitter Direct Message to confirm on September 12, 2016. You must follow @hhgregg on Twitter in order to receive a winner announcement tweet. Potential prize winner will be required to respond to the winner announcement tweet with a reply direct message within forty-eight (48) hours of being announced as the potential prize winner or such potential prize winner will be disqualified.
